

Curtin Catch-Up Giveaway – Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 (“Curtin University”).
5. The Curtin Catch-Up Giveaway (“the competition”) commences at 10am Australian Western Standard Time (AWST) on 29/08/2025.
6. The closing time for entering the competition is 11.59pm AWST on 12/09/2025.
7. Entry to the competition is limited to any current student studying at Curtin University in Australia.
8. To enter the competition, the entrant must complete the following steps between 29 August 2025 and 12 September 2025:
 - a) Subscribe to the Curtin Catch-Up Newsletter using their student email address (firstname.lastname@student.curtin.edu.au)
9. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
10. Entrants can only enter the competition once.
11. Staff employed by Curtin University and their immediate family members are not eligible to enter the competition.
12. There will be one (1) prize pack with one (1) winner, which includes:

13. There will be one (1) winner chosen at 10am Australian Western Standard Time on 15/09/2025 at Curtin University. The selection will be made by a random number generator: <https://www.random.org/>
14. The prize winners will be contacted via email within seven (7) days of the winner selection.

If the prize winners do not respond to claim their prize within seven (7) days of notification, another judgement of entries and redraw will be conducted within fourteen (14) days of the original draw date, in the same location, and with the same method. Re-draws will continue in the same manner until all prizes have been claimed by prize winners.
16. If the prize winners are under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
17. The prize must be collected in person by the prize winners or parent/legal guardian.
18. If a prize winner who has been contacted and been made aware of their prize winning, and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize
