

FBL Insight Survey Competition– Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Curtin University, GPO Box U1987, Perth, Western Australia, 6845 (“Curtin University”).
5. The FBL Insight Survey Competition (“the competition”) commences at 5pm Australian Western Standard Time (AWST) on 21 May 2026.
6. The closing time for entering the competition is 11.59 pm AWST on 1 July 2026.
7. Entry to the competition is limited to current students enrolled in Faculty of Business and Law units at Curtin University in Australia.
8. To enter the competition, the entrant must have completed and submitted an Insight Survey between 6 May 2026 and 1 July 2026.
9. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
10. Entrants can enter the competition with each Insight survey they submit. One (1) survey submitted = 1 competition entry.
11. Staff employed by Curtin University and their immediate family members are not eligible to enter the competition.
12. There will be four (4) prizes with four (4) winners. Each prize winner will receive one (1) of the following prizes:
 - a) One (1) iPad (A16) 11" WiFi 128GB valued at \$587.00, or
 - b) One (1) iPad (A16) 11" WiFi 128GB valued at \$587.00, or
 - c) One (1) Microsoft Surface Laptop Go 3 12th Gen Intel Core valued at \$1,429, or
 - d) One (1) Microsoft Surface Laptop Go 3 12th Gen Intel Core valued at \$1,429.
13. There will be four (4) winners chosen at 10am Australian Western Standard Time on 6 July 2026 at Curtin University. The selection will be made by a random number generator: <https://www.random.org/>
14. The prize winners will be contacted via email within seven (7) days of the winner selection.
15. If the prize winners do not respond to claim their prize within ten (10) days of notification, another judgement of entries and redraw will be conducted within fourteen (14) days of the original draw date, in the same location, and with the same method. Re-draws will continue in the same manner until all prizes have been claimed by prize winners.
16. If the prize winners are under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
17. The prizes can either be collected in person by the prize winners or parent/legal guardian, or Curtin University will mail the prizes to the winners if the winners are located outside the Perth Metropolitan Area.
18. If a prize winners who have been contacted and been made aware of their prize winning, and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize within twenty-one (21) days of this contact, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method.

19. The prize winners, or if under the age of 18 years their parents or legal guardians, may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving their prize.
20. The prize winners will be responsible for all costs associated with collecting and using the prize.
21. By entering the competition the entrant agrees that they are over the age of 18 years, or if under the age of 18 years, have their parent's or legal guardian's consent to enter the competition.
